HOA Officers and Board members are having to do way more work on the pool that they should not have to be doing! 3 new lifeguards have been hired, so hopefully they will be able to start soon, and we can go back to our regular pool hours! Please remember, that we are not the only HOA dealing with this issue, Willow Brooke and The National are also using this company.

We are hoping to have a Neighborhood/Back to School Cookout at the end of the month, Saturday, July 30<sup>th</sup>. Be watching for more information on this event.

#### Pool

- We are continuing the pool hours for now from Noon-7pm daily until we can resolve the staffing issues but we did just get some new lifeguards certified and hope to go back to full hours in a week or so. We may have a couple of days at the end of this week where we don't have guards though and will need to close. Communication with the new pool mgmt. company continues to be unacceptable − we are taking on more responsibility than intended and other pool of theirs continue to have a similar experience. We continue to try for a weekly call where we go over operating state and plans to address lack of execution on the contract. Swim team banquet is this Thursday evening and they have paid their fee for the year. The sound system for the pool went out so we purchased a nice rolling speaker that lives in the guard stand\ and can be used for other events like the Halloween party.

Lawn Care: Lawn care and mowing is going well. John Spottswood said he will spray the area around the pool where poison ivy is growing. We will try and contact a person to do some trimming around the pool and tennis courts.

  - Request was made to see about budgeting for tree trimming around the pool to help keep debris out of the pool area and for poison ivy removal between the pool and tennis courts.

- Rentals continue to be booked steadily for the summer months.
