Mike is reviewing liens to see if some should be removed and others should be added.

Pool

Everything is on track for getting the pool ready to open. We have 4 lifeguards returning from last year, and 4 new lifeguards. We believe that the swim team will still use our pool for practice. Please watch our New Mark Residents Facebook page for Pool Key pick up dates. We received a second bid for the Pool Shade Structure from Dwayne Dennison. His bid was less than the first bid, and he will be able to install the shade before the pool opens, and will get the needed permits. The company that gave us the

first bid has never gotten back with us, and we had no contracts with them. After discussion, a vote was taken, the motion to let Dennison Construction install the shade passed unanimously.

- First payment of \$18k complete and they have been out to start checking things already
- Mike reached out to swim team since we haven't heard anything recently
- USA Pool is still invoicing us so Mike is preparing a cease and desist letter to be sent

Spring Clean Up has been rescheduled to April 29, Beginning at 9am. We have made arrangements with the city to have Dumpsters at the Clubhouse on June 17 and Oct. 21. There will be 2 each time, one for household trash, the other for leaves and brush. Thank you to Rick Head for making these arrangements with the city.

- Payment made with KCMO for 3 dumpsters timing TBD; first month available is May
- Pending items:
 - i. Lollipop request vetting for future inclusion in 2023
 - ii. Aerator conversation check with Chris Mahan on this and find maintenance concerns.....potentially look at grants for adding those (remind James in April); Blue Valley see if they can bid anything around this; check on electrical box
- Clubhouse/Tennis Courts

The Clubhouse is booked for the next two months. The potholes at the parking lot entrance are going to be filled. Another deep clean of the bathrooms will be done the first part of June.

- Weekend rentals busy into June; calendar is filling up
- Tennis court renovation is well underway; weather has not been cooperating but they have been engaged. Gravel under the court was deeper than expected so might take more fill dirt than planned.
